Each participant must be covered by valid sports insurance and civil liability insurance, in accordance with current Belgian legislation. 2. Each player must hold a valid player's license and must not be suspended or subject to any ongoing disciplinary sanction. 3. It is the sole responsibility of the Association to ensure compliance with these obligations.
